Weeks 36 & 37: Quillayute River from mouth upstream to confluence of Bogachiel and Leyendecker bridge on the Sol Duc River.

Week 38: Reservation Only. Powerlines to Mouth of River

Opening /Closing Periods for 8/31/2026 through 11/11/2026

Opens at 6 AM on specified day of the week

Closes at 6 PM on specified day of the week

Opening /Closing Periods for 11/16/2026 through 12/11/2026

Opens at 7 AM on specified day of the week

Closes at 3 PM on specified day of the week

Gear Restrictions

One net only, set or drift, per boat

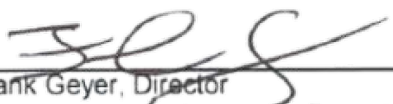
Weeks 36 - 46: If Sol Duc stage height falls below 15.30 - 7 3/4" minimum monofilament mesh, 25ftm max net length, set net only

Week 38 until Further Notice: No gear restrictions on Reservation except for 25 ftm max net length in the Navigational Channel.

Notes:

- 1.) Schedule may be modified for conservation or other management requirements
- 2.) Schedule adjustments or closures will be posted.
- 3.) All other regulations as per Quileute Tribal Fish Ordinances 2019-A-40

From Harbor Entrance to the mouth of the Quillayute River both sides, reflective tape or lighted device must be attached to the end of the net closest to the Navigational Channel.
